1. All accounts are payable by the 20<sup>th</sup> day of the month following the date of the invoice. If the account is not paid within 30 days after the due date, our debt recovery agency may charge you a fee equal of 25% of the unpaid portion of the price, but not less than \$25.00. Where the total agency, legal and other costs arising from recovery of any amount owing exceeds the debt recovery fee charged, our agent is also entitled to recover such additional costs from you. This clause is intended to be for the benefit of and be enforceable by our debt recovery agency under the contracts (Privacy) Act 1982.
  
2. I/We agree to indemnify you against all costs, whether commission, legal fee or otherwise, incurred by you or your duly authorised agents relating to any moneys, goods and services that may be outstanding from time to time pursuant to the terms of this agreement.
  
3. I/We agree that the terms of trade are strictly settlement on or before the 20<sup>th</sup> of the month following the month of delivery and that KLASSIC ICE AND FIRE LTD will be entitled to charge interest at the rate of 18 % per annum (1.5 % per month) on all amounts that have not been paid in full by the 20<sup>th</sup> of the month following the month of delivery.
